



Prescribed Fire Training Exchange Notes from the Field

Flint Hills, Kansas

March-April, 2011

Participants in this exchange demonstrated that by working together, ambitious burning goals can be accomplished. This interagency crew was mobilized and hosted in the Flint Hills region of Kansas for two weeks. Consisting of managers from the Army's Fort Riley, U.S. Fish and Wildlife Service fire staff from the Maries de Cyngne and Flint Hills refuges, and staff from the Tallgrass Prairie National Preserve co-managed by the National Park Service and The Nature Conservancy, the training cadre coordinated the burning of about 6,000 acres and provided training opportunities for 11 firefighters. This training also included an introduction to local ecology and land use practices, monitoring protocols, and fire control tactics and strategies. In addition, the crew of cadre and trainees responded to a wildfire, where they integrated with the local county Incident Command System and served as a taskforce of engines on the fire, protecting structures, ranch infrastructure and hay.

Trainee positions ranging from burn boss to prescribed fire crewmember were offered at this exchange, with qualified fire practitioners mentoring and evaluating trainees. Fire managers from the Kansas Forest Service and Fort Riley, U.S. Forest Service firefighters from New Mexico and municipal firefighters from several Kansas communities worked alongside each other throughout the exchange. burned a mix of prairies and woodlands, learning from each other and burning increasingly complex units. Gaining experience and local knowledge as they burned, for example, the crew began burning into the evening when spotting potential was reduced and winds were lighter.



One evening, after responding to a wildfire, the crew returned to the preserve and conducted a controlled burn, treating 2,000 acres of grassland. Above, the fire is lit for the burn.
