The Northern California Prescribed Fire Council met in South Lake Tahoe for their fall meeting in early November; with over 100 participants, the Council continues to draw new participants. Following a full day of presentations, 50 participants bundled up and embarked on a field tour of the snowy slopes of Incline Village at the north end of Lake Tahoe. “The field trip was stunning,” according to Jeremy Bailey, “the North Lake Tahoe fire department is getting it done! They are working and burning in places that most people avoid. It was inspirational to see prescribed fire being conducted within the city limits, on private land, in between homes. They are taking bold action to protect their community, and they are doing it right.”

The NLTFPD has worked with the community long enough that they are able to rely mainly on broadcast burns (*right*) for fuel treatments; these are conducted over a longer season than is typical in the region.
