## News from the Field

**California:** FireScape Mendocino held a two-day **public workshop** last week, with 40 people taking part in a field tour and 60 people engaging in the workshop session. The [news story](#) “Two-Day Workshop Focuses on **Planning for Wildfire Resilience and Post-Fire Restoration**,” posted before the workshop, gives a good outline of the agenda and goals of the gathering, which included an introduction to potential operational delineations (**PODs**). The first [outcome of the workshop](#) was a **map** of the **Mendocino National Forest** and adjacent lands with draft POD boundaries and related information that interested parties can **explore and comment on**.

**California:** The **first Santa Barbara TRES** took place last week, bringing some “**good fire**” to **UC Santa Barbara’s Sedgewick Reserve**, according to [local news](#). The **46 participants** also completed a couple days of pile burning, which they turned to after substantial October rains caused some of the planned broadcast burn units to green up too much to burn.

**California:** The **Resource Conservation District of Butte County** hosted **three training weekends** in October as part of its [fall Cal-TRES](#), building squad communication skills, learning about cultural fire and fire ecology, and completing S-219 (Firing Operations). Participants will now engage in **on-call burning** through February.

**California:** The [article](#) “**Tribe and Partners Light up a Forest** to Restore Landscape in California” in *Mongabay* talks about the **Somes Bar Integrated Restoration Project** in the context of **ongoing challenges** faced by tribes wanting to use fire for cultural purposes. (The story is illustrated in part with photos from the recent **Karuk WTRES**.)

**Maine:** **Amanda Mahaffey** ([amanda@forestguild.org](mailto:amanda@forestguild.org)) captured a **full day** as a member of the **Incident Management Team** on the first TRES in the Northeast in her [essay](#) “2022 ME-TRES: A Day of ‘Fire Vacation’ in Southern Maine.”

**Maryland:** Two weeks ago, in the **Potomac Headwaters FLN** landscape, TNC planned and led a **90-acre burn with public viewing** at Rocky Gap State Park. It was the **Maryland Park Service’s first burn**, and it was accomplished in partnership with the DNR Forest Service and DNR Wildlife and Heritage Service, National Park Service, Allegany College of Maryland and the Chesapeake Conservation Corps. A [press release](#) was published in the local paper the day before, and **Donnelle Keech** ([dkeech@tnc.org](mailto:dkeech@tnc.org)) and the park manager **described the burn on Facebook Live** ([recording](#)). According to **Deborah Landau** ([dlandau@tnc.org](mailto:dlandau@tnc.org)), “It wasn’t a big burn, but was an important first burn, and I think the viewing station really **helped folks understand the what and the why**.”

**Tennessee:** **Katherine Medlock** ([kmedlock@tnc.org](mailto:kmedlock@tnc.org))—co-lead of the **Great Smoky and Unaka Mountains** and **Southern Cherokee** landscapes in the **Southern Blue Ridge FLN**—was [interviewed](#) in the latest newsletter from the **Oak Woodlands & Forests Fire Consortium**.

## Input Requested: Wildfire Commission / Virtual Tour

**Wildfire Commission:** The federal **Wildland Fire Mitigation and Management Commission** has held its first couple of meetings, and several workgroups have begun discussing several topics. Other workgroups will take up the remainder of the topics over the next few months. Starting December 1 you can currently **submit recommendations** [via a web form](#) to the group working on **post-fire issues**. (All topics, and when recommendations will be accepted for each, are also on that page.)

**Virtual Tour:** **Penn State University** and the **Pacific Southwest Research Station** recently created a virtual field tour to **help audiences visualize** what different types of **thinning and prescribed fire treatments** look like. Before releasing the tool, they are seeking feedback (through a brief survey); input from forest managers, fire managers or policy makers is particularly needed. ## Articles & Reports: Landscape-Scale Rx / Southern Apps Wildfires / Great Plains Rx / Marshall Fire FLA / Incidents & Accidents

**Landscape-Scale Rx:** The most recent Rocky Mountain Research Station *Science You Can Use* [bulletin](#) "Getting More Fire on the Ground: Landscape-Scale Prescribed Burning **Supported by Science**" is framed in light of the Forest Service's **Confronting the Wildfire Crisis** strategy. It summarizes—and shares further readings in—several subject areas, including social science, tribal perspectives, wildlife considerations, smoke and PODs.

**Southern Apps Wildfires:** The [article](#) “**Drivers and Ecological Impacts** of a Wildfire Outbreak in the Southern Appalachian Mountains After Decades of Fire Exclusion” looks at the **fall 2016 outbreak** of more than a dozen wildfires. For a quick overview, there’s a summary of the article in the latest [CAFMS newsletter](#).

**Great Plains Rx:** The [article](#) “Barriers to Prescribed Fire in the U.S. Great Plains, Part I: **Systematic Review** of Socio-Ecological Research” includes a good diagram summarizing “**barrier builders**” and “**barrier busters**,” including their relationship to membership in a prescribed burn association. [Part II](#) of the review covers **solutions**.

**Public Participation:** The [paper](#) “Pandemic-Era Participation in **Public Lands Governance**: Lessons From the USDA Forest Service” uses **Trinity of Voice theory** concepts—**access, standing and influence**—in discussing the results from two peer-to-peer learning sessions among Forest Service staff and a case from the National Forests in North Carolina.

**Marshall Fire FLA:** The Wildland Fire Lessons Learned Center has posted a **facilitated learning analysis** of the December 2021 Marshall Fire as an **expansive and detailed** [Story Map](#).

**Incidents & Accidents: USDA Forest Service** Research and Development has released an in-depth [metareview](#) covering a **ten-year period** (2007-2016). Available in **several formats** (pdfs, audio book or Story Maps), the review addresses **five major themes**—fatalities and injuries, fiscal incentives, society, ecological soundness, and communication/work environment. The Restoring and Managing Longleaf Pine Ecosystems Research Work Unit (RWU) of the Southern Research Station (SRS) plans to advertise a vacancy for a permanent, full-time, Research Biological Scientist position. The position will be filled at the GS-12 (currently, \$79,363/yr to \$103,176/yr) level, plus standard Federal benefits. The duty station is the G.W. Andrews Forestry Sciences Lab in Auburn, AL. In addition to the Longleaf Pine RWU (SRS-4158), the Auburn lab currently houses researchers and support personnel from several other units of the SRS, including the Forest Operations (SRS-4703) and the Utilization of Southern Forest Resources (SRS-4704) RWUs, Forest Inventory and Analysis (SRS-4801); and staff from Partnerships and Strategic Initiatives.

The Longleaf Pine RWU's mission is to provide knowledge and strategies for restoring, managing, and sustaining longleaf pine ecosystems in the southeastern United States. The RWU operates as a part of the SRS's Center for Forest Restoration and Management under the broader science area of Resource Management and Use. SRS-4158's web page (<https://www.srs.fs.usda.gov/longleaf/>) provides more information about the RWU, including our [charter](#).

**Duties**

The scientist develops studies that support the mission of SRS-4158 across the range of longleaf pine, focusing on ecosystem goods and services related to the understory and its pine-dominated overstory. Geographically, this focuses the research on the longleaf pine-dominated ecosystems of the Atlantic and Gulf coastal plains, Sandhills, Piedmont, and southern Appalachian Mountains. Potential avenues of fruitful research may include community assembly, invasion ecology, natural and anthropogenic disturbances, management impacts on restoration, fire and fire effects, carbon dynamics, nutrient cycling, vegetation-water relations, and modeling, amongst other possibilities. The work should address basic and applied questions concerning the complex relationships in longleaf pine-dominated systems between the under- and overstory, community dynamics, natural disturbances (especially fire), stand management practices, human communities and societal needs, and landscape dynamics.

More specifically, the scientist plans and conducts research on the biotic, abiotic, and socioeconomic factors influencing the many goods and services offered by the longleaf pine ecosystem. Longleaf pine-dominated open forests, with their substantial understory richness and complex community relationships, have become a public lands restoration priority range-wide. To better these restoration efforts and

outcomes and broaden our knowledge of pine-dominated landscapes in general, the scientist will develop a research program focused on past land use of historical ecosystems and desired future conditions under a changing environment. In addition, the scientist will work with colleagues to study the impacts of management and restoration treatments on understory communities (and vice versa). It is expected that this work will also integrate spatial information from individual plants to populations to stands to landscape mosaics across multiple scales using observational and experimental research. These data may be used to create, parameterize, refine, and test models related to longleaf pine ecosystems, with fire as one of many variables to manipulate. Other fire-related research themes could include studies on local- to landscape-scale prescribed burning or research into fire behavior in unrestored and restored longleaf pine ecosystems. In general, the research by the scientist should also provide information on assessments of the costs and benefits of longleaf pine restoration, including the risks of restoration and alternatives, the value of non-traditional ecosystem goods and services, the potential influence of threatened and endangered species, and/or the impacts of fire (prescribed or otherwise).

This research program should fall within the scope of the unit's research mission and supports the goals of the SRS, Region 8 of the National Forest System, the Forest Service, and the USDA. For instance, studies of the scientist will support the agency's objectives for longleaf pine restoration, including Region 8 initiatives to increase the scope and pace of longleaf pine restoration. This research should also support the needs of a diverse assemblage of agency collaborators, from the timber industry and the Southern Group of State Foresters to university partners, NGOs, other state and local agencies, and support efforts such as America's Longleaf Restoration Initiative. The full cycle of research, from concept development to securing support to implementing studies to publication and dissemination of the work, will be required. The scientist will determine key aspects of the experimental design and will serve as an expert in the study of ecosystem goods and services of longleaf pine for the SRS, the Forest Service, practicing foresters and land managers, and the scientific community in general. Additionally, the scientist will be an active liaison with the other federal researchers, university faculties, the National Forest System, other federal and state agencies, non-governmental organizations, forest industry and non-industrial private forest landowners involved in improving forest management practices, to disseminate research findings and obtain guidance concerning research that promotes scientific forestry.

The scientist may also exercise the full range of supervisory duties for a Research Support Team and provide additional administrative support; these responsibilities will constitute 10% or less of the scientist's time. In addition to helping the Research Support Team with the operations of the Escambia Experimental Forest, a public-private partnership located in Brewton, Alabama, the successful applicant will also be an active contributor to the Experimental Forest Network of the SRS, working with other Station scientists and staff to further develop this effort.
